

Renewal form | Service contract

A service contract is included with all new perpetual licenses and is valid for one year. A yearly service contract gives access to software updates, database updates and technical support.

An active license requires an annual renewal of Service Contract from the second year on. Service contracts are renewed in communication with Miljögiraff and contact person at least 5 weeks before expiry date.

A license without service contract for one full year is considered ended and cannot be updated again. For new updates after one full year without service contract a new license is required. Any time prior to one full year after the last expiry date the service contract can be resumed from the last expiry date again.

Prices are in euro (€), exclude VAT and import duties, and are valid until December 31, 2025. Price adjustments are based on the consumer index and are communicated well in advance (30 days).
